| HB 4008 | Amends Sec. 101 of the School Aid Act to reinstate a minimum number of Days as well as Hours of Pupil Instruction – drafted to follow required in 380.1284 of the School Code (however, in Dec. 2006, 380.1284 was enacted to follow Section 101 of the School Code) | House Education Committee since 1/22/07 |
| HB 4042 | Amends the School Code 380.1561 et al to increase the Compulsory Attendance Act from age 16 to 18 | House Ed |
| HB 4073 | Amends the School Code 380.1147 to add Kindergarten as a required grade | House Ed |
| HB 4091, HB 4162 | Requires school districts to adopt a anti-bullying policy; it specifies classes of students; required MDE to adopt model policy (may require public hearing to adopt policy) | Passes House, Sen. Govt. Ops |
| HB 4200 | Amends the School Code to prohibit the use of public funds for rewarding attendance on school count days | House Ed |
| HB 4243 | Amends the School Code to require student record transferred to include discipline, attendance and health information | House Ed |
| HB 4326 | Provides standards for counting WBL for Grade 8 students | House Ed |
| HB 4529 | Eliminates provision for written agreement for Sec. 105c | House Ed |
| HB 4636 | Amends the School Code 380.1284 to allow a post-Labor Day start of school if enrichment programs are offered during breaks | House Ed |
| HB 4662 | Amends the School Code (380.1147) and Compulsory Attendance Act (380.1561) to require mandatory Kindergarten attendance | House Ed |
| HB 4815 | Provides for picture ID and signed form for child pickup | House Ed |
| HB 4875 | Provides clarification for granting Post-Secondary Options credit towards high school completion | House Ed |
| HB 4924 | Prohibits operating a school or educational program outside a district's boundary without written consent | Senate Ed (see SB 32) |

| SB 11 | Amends the Sec. 380.1561 et al to increase the Compulsory Attendance Age from 16 to 18 (same as HB | Senate Education Committee |
| SB 32 | Amends the School Code to prohibit a school district from operating outside their boundaries without written permission | Senate Ed (see HB 4924) |
| SB 107 | Requires policies against bullying and harassment at school | Senate Ed (see HB 91) |
| SB 162 | Amends the School Code (380.1147) and Compulsory Attendance Act (380.1561) to require mandatory Kindergarten attendance | Senate Ed (see HB 4662) |
| SB 403 | Amends the School Code 380.1278a, .1278b to allow for Personal Curriculum Modifications to the Michigan Merit Curriculum for transfer students | Passed Senate; House Ed |
| SB 488-90 | Amends School Code 380.1561 et al to require school districts to adopt a Truancy Policy, gives Family Court jurisdiction over truant students, and links attendance to maintain drivers' license. | Senate Ed |
| SB 549 | Provides for common school calendar within ISDs and constituent school districts | House Ed |
